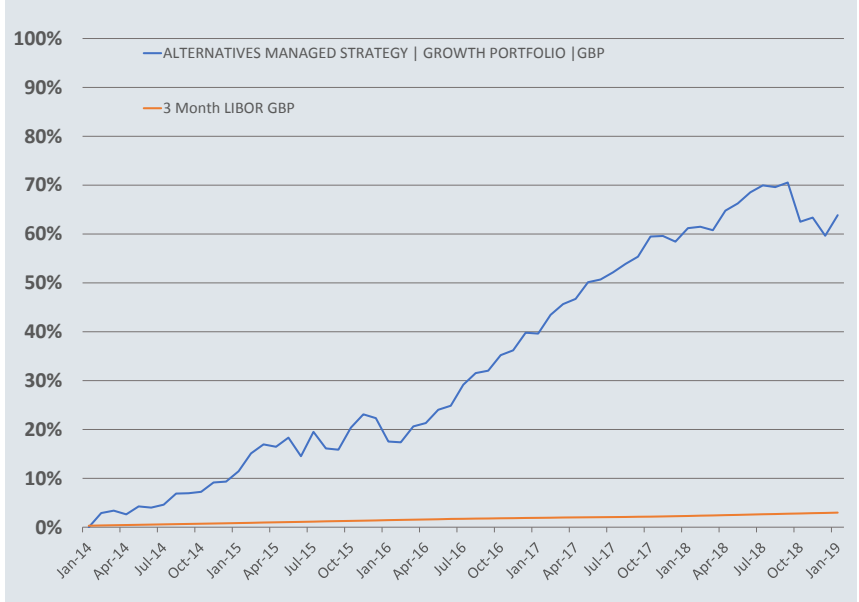

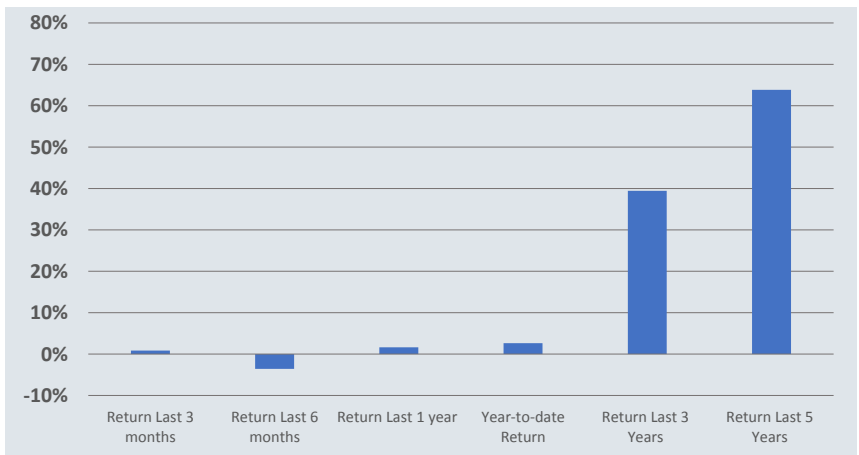

Rolling 12 Months Annualised Volatility:



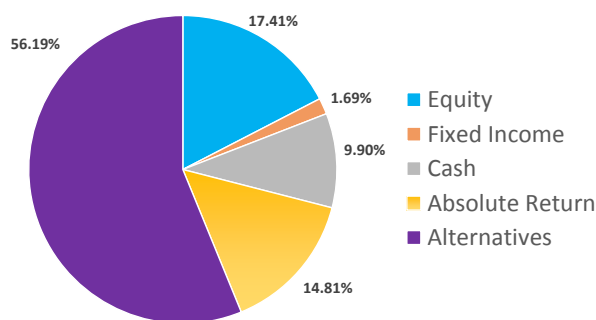

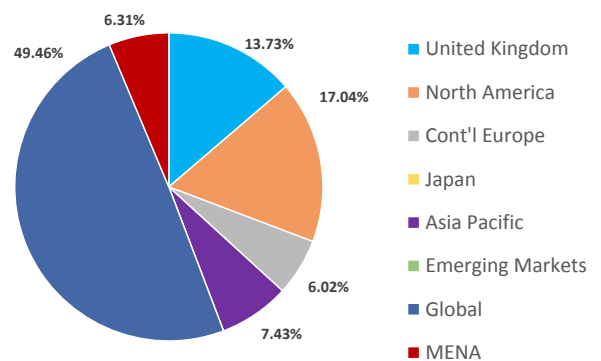
